ABOUT HEALTHeID

Born from the European Commission proposal to support countries in integrating Electronic Identification, Authentication and Trust Services (eIDAS) with cross-border services, HEALTHeID aims to improve quality of health services provided to EU citizens by enabling their access to digital health records and services in Europe, ensuring digital transactions security.

OBJECTIVES

HEALTHeID strives for the transferability of the reference implementation to all Member States. For this end, TRANSFERATHON comprises a set of technical workshops on the proposed architecture, eIDAS Connector, modifications of the NCPeH and Portal as well as a set of practical demonstrations of NCPeH – eIDAS integration for the HEALTHeID with its piloting countries – Portugal, Greece, Italy and Czech Republic and other interested/ready Member States.

SCOPE AND METHODOLOGY

TRANSFERATHON is meant to demonstrate live the practical use of NCPeH–eIDAS connector developed for the eHealth domain, focusing the validation of electronic identification (eID) in health domain by connecting eIDAS node with NCPeH environments, ensuring the integration and communication between both assets (OpenNCP & eIDAS), meaning guaranteeing the connectivity between the different components and environments that will simulate eIDAS and NCPeH of their respective country. To this end, the proposed Agenda will consist of two different environments: one Functional, other Technical.
